In this booklet you will find everything you need to know to get you up and running with Quicken 2011, whether you are a new or existing user. We strongly recommend that you read this booklet carefully and follow the steps outlined to ensure your installation process is as smooth as possible.

If you have anti-virus software installed on your PC, it is recommended that you disconnect your Internet connection and then disable your anti-virus software, as it may interfere with software installation.

If you are upgrading from an earlier version of Quicken, pay special attention to the notes describing features that have been changed or added to Quicken since your last upgrade. You may need to perform additional steps in the upgrade process, depending on how old your current version is. The headings in each section provide a guide to finding the instructions relevant to you.

System Requirements

To install and use Quicken 2011 you need:

- IBM® or compatible Pentium® II 300 (Pentium III 450 recommended) with 512 MB RAM
- Microsoft® Windows® XP/Vista/7* operating systems
- Compatible with Microsoft® Office XP/2003/2007
- 185 MB of disk space for Quicken installation, plus 55 MB for Microsoft Internet Explorer if IE 6.0 (provided on installation CD).

Please note HUBB Investor software requires 5GB disk space. (See www.hubbinvestor.com for more details)

- Microsoft Internet Explorer® 6.0 or higher
- 800 x 600 resolution (SVGA 1024 x 768 with 16-bit colour recommended)
- Any printer supported by Windows® XP/Vista/7* operating systems
- Double speed CD-ROM (6x or higher recommended)
- 56 Kbps modem (high speed Internet access recommended). Internet access is required for all online features and services, such as online investment tracking (HUBB Investor software requires cable, ADSL or broadband internet access, see www.hubbinvestor.com for more details)

**Windows 64 bit support for Window 7 only.*

Reckon recommends you install the latest service packs for Microsoft® Windows and Internet Explorer.

Existing Quicken users

Changes for 2011

Quicken includes many changes and new features in this release. An overview of changes and features you should note is provided below.

Your Installed Quicken Products

In most cases, Quicken 2011 will uninstall any Quicken product previously installed on your PC. The data files will remain in the same location they were in before the installation of Quicken 2011.

To ensure a smooth upgrade process, we recommend that you uninstall all previous versions of Quicken before installing Quicken 2011. It is important you make a backup of your Quicken files before doing so.

Changes to Cash Flow Forecasts

After upgrading, Quicken may not be able to recognise cash flow scenarios that you have saved in a previous version. If this occurs, you will need to re-create the forecast after the upgrade.

To re-create the forecast after the upgrade:

1. Choose **Planning** menu > **Cash Flow Forecast**.
2. Choose **Options** > **Select Accounts** to customise the accounts for the scenario. Click **OK**.
3. Choose **Options** > **Manage Scenarios**.
4. Click **New** and enter a **Scenario Name**, then click **OK** to save the new scenario.

Updating your stocks from Quicken Version 8 or earlier

Quicken includes new features for tracking your investments, such as the ability to download stock prices from different exchanges (Australia, NZ, US). If you have upgraded from Version 8, the exchange and asset class for each security will be set to your default country. You must

specify the asset class and exchange for each security after you have upgraded to Quicken 2011.

To specify the asset class and exchange for a security:

1. Choose **Investing** menu > **Security List**.
2. Highlight the individual security and then click **Edit**. You can assign an exchange and asset class from the relevant drop-down lists. If a '**Symbol Change Affects Price History**' message appears, click **OK** to copy the quotes.

Term Deposit

Term deposits are fixed-term bank investments, paying a fixed rate of interest over the term of the deposit. In Quicken 2011 Personal Plus and Home & Business, you can now set up "Term Deposit" accounts to track your real-world investments.

To set up a Term Deposit account:

1. Choose **Investing** menu > **Go to Investing Centre**.
2. Click **Today's Data** in the right-hand corner of the screen.
3. In the **Investment & Retirement Accounts** snapshot, click **Add Account**.
4. Select **Term Deposit** then click **Next**.
5. Follow the on-screen instructions.
6. When Quicken prompts you to set up a Term Deposit security, click **Yes**.
7. Select **Add new Security** and click **OK**.
8. Set the "Security Type" to **Term Deposit** and give it a unique name then follow the on-screen instructions.
9. Quicken will alert you on the day that your term deposit matures. You can record your interest by selecting the Term Deposit account, then click **Enter Transactions**. Record your interest by choosing **Record Income Event** or **Miscellaneous Income**.

Quicken New Zealand - KiwiSaver

If you are a Quicken New Zealand Personal Plus or Home & Business user, you can now set up a KiwiSaver account in Quicken 2011, which is a savings initiative to help set you up for your retirement. You will build up your savings through regular contributions from your pay through the KiwiSaver wizard. A list of KiwiSaver providers is now available in Quicken.

To set up a KiwiSaver account:

1. Choose **Investing** menu > **Go to Investing Centre**.
2. Click **Today's Data** in the right-hand corner of the screen.
3. In the **Investment & Retirement Accounts** snapshot, click **Add Account**.
4. Select **KiwiSaver** then click **Next**.
5. Follow the on-screen instructions.
6. You can set up a paycheque for regular contributions when Quicken prompts you to do so.

Data Converter[^]

Microsoft has discontinued their personal finance product - Microsoft® Money on the 30th of June 2009. If you were a Microsoft® Money user, the Data Converter allows you to transfer your Microsoft® Money transactional data to Quicken.

You can choose to install Data Converter while you install Quicken 2011. Alternatively, browse your CD and navigate to `d:\HAB\DISK1\mny2qdf` folder (where d: is your CD-ROM drive) then run **setup.exe** to install.

[^]You can use the Data Converter tool to transfer your transactions to Quicken 2011 from Microsoft Money® 2008; however Microsoft Money® and Quicken operate using different accounting methods. Due to this limitation, the Data Converter attempts to achieve the best outcome during the conversion process.

It is highly recommended that you read the **Quicken Data Converter** document (browse your CD and navigate to `d:\HAB\DISK1\mny2qdf`

folder where d: is your CD-ROM then open **2011_Data_Converter.pdf** so that you understand and accept the limitations of the Data Converter.

Reckon Tools HUBB Investor*

Reckon Tools HUBB Investor is now available to you in Quicken 2011 Personal Plus and Home & Business. It is a powerful tool which combines technical and functional analysis to help you analyse stocks for your long term portfolio or short term trading opportunities. It includes charting tools with a daily data feed from the ASX and NZX, company health check and much more.

**Reckon Tools HUBB investor is a third party tool from HUBB Financial Group, proudly brought to you by Reckon Limited.*

You can choose to install HUBB Investor while you install Quicken 2011. Alternatively, browse your CD and navigate to d: \HAB\DISK1\HUBB folder (where d: is your CD-ROM drive) then run **hubbinvestorsetup.exe** to install.

To run Reckon Tools HUBB Investor:

1. Choose **Tools** menu > **Reckon Tools HUBB Investor**.

BAS Report

The BAS Report has been enhanced by allowing you to generate reports even if values for #4, 7D and 7C are not applicable to your situation.

To run a BAS report:

1. Choose **Reports** menu > **Business**.
2. Click **BAS Report**.

Add a security

In Quicken 2011, the Cost Basis screen in the wizard for adding a new security has been removed to speed up the process.

To add a new security:

1. Choose **Investing** menu > **Go to Investing Centre**.

2. Click **Today's Data** in the right-hand corner of the screen.
3. In the **Watch List** snapshot, click **Add a security**.
4. Follow the on-screen instructions.

FIDO Calculators

The ASIC FIDO calculators, including Superannuation calculator, Credit Card Calculator, First Home Saver Account calculator and Managed Funds Calculator which were available to you in previous releases of Quicken are no longer available in Quicken 2011.

Tax line items and personal income threshold

In Quicken Personal Plus and Home & Business releases we include tax features which allow you to estimate your taxable income for a particular financial year.

Tax line items have been updated for the 2010/11 financial year to conform with the ATO Tax Pack released in July 2010. Income tracking, tax related expenses as well as Income Tax Summary report have been updated to reflect the changes.

Quicken has been updated with the new personal income thresholds for the 2010/11 financial year. The personal income thresholds are used to estimate the taxes payable at the end of each financial year.

Quicken data file with No Categories

In Quicken 2011 when you create a new file, you will now have the option to create the file with no default list of categories. This is particularly useful if you or your accountant wishes to set up a customised set of categories for reporting purposes.

If you are creating a new file with no categories, be aware that the tax lines (questions from the Tax Pack) will not be available to you. Seek advice from your Accountant or Accredited Advisor if you are selecting this option.

Express Setup interview

When you create a new Quicken file in the Express Setup interview, you can now select whether your primary chequing account is for business or personal use and also set the tax tracking attribute for it.

This feature applies to Quicken 2011 Home and Business only.

Quicken New Zealand – Tax Changes

Quicken New Zealand has been updated with the latest GST rate of 15% as per the Budget 2010 changes.

Recent versions of Windows and User Access Control

If you are using Quicken 2011 on Windows Vista or Windows 7 it is recommended that you leave the default setting for User Access Control (UAC) during installation and use.

Reckon does not support Quicken in a non-UAC enabled Windows Vista or Windows 7 configuration.

Upgrading a data file from Quicken 2004 or earlier versions

If you are upgrading from Quicken 2004 or earlier versions to Quicken 2011 and have passwords associated with your data files, you should remove passwords from your data files before upgrading.

Savings accounts created in Quicken 2004 or earlier versions do not include an **Account Location** field. However, in Quicken 2011 the **Account Location** field cannot be empty. Thus, after upgrading from Quicken 2004 or earlier versions

to Quicken 2011, savings accounts will display “**Spending**” in the **Account Location** field.

The new **In / Out / What’s left** feature allows users to immediately see where their money is going using various charts and tables. This feature displays information using the savings accounts that show **Spending** in the **Account Location** field.

If you are upgrading from Quicken 2004 or an earlier version to Quicken 2011 and have savings accounts set up, you should change the value in the **Account Location** field from **Spending** to **Saving**. This ensures the **In / Out / What’s left** feature displays the correct information.

To change the value in the Account Location field:

1. Place the cursor over the account name in the **at-a-glance** bar.
2. Right-click on the account name and select **Edit Account**.
The **Account details** window opens.
3. Change the **Account Location** field from **Spending** to **Saving**.

If you upgrade a data file that contains a linked account

The Quicken 2011 **Investment Activity Report** reports on all transactions from linked accounts. New transactions entered in the linked accounts in Quicken 2011 will continue to appear in the **Investment Activity Report**.

Upgrading from CashBook 2003 or CashBook 2004

The **Itemised Category Report** in Quicken 2011 does not include account balances forward by default.

To include account balances forward:

1. Open the **Itemised Category Report**.

2. Click **Customise**.
3. Click the **Advanced** tab.
4. Select **Include All** from the **Transfers** drop-down list.

If you have at any stage had 'return of capital' transactions entered in an investment account that has a linked bank account, the **Itemised Category Report** will not add the return of capital transactions to the total.

Opening your original data file after upgrading to Quicken 2011 from any earlier version of Quicken or CashBook

When you upgrade to Quicken 2011, a backup copy of your original data file is automatically placed in a folder called **OldFiles**, which is located in the same folder as the data file you are upgrading. Use this backup copy if you need to view your original file in your previous version. You can choose **File** menu > **Restore** or **File** menu > **Open** to open the file.

Opening Quicken 2009 and 2010 data files

Quicken 2009 and 2010 data files will not go through the upgrade process and they should open without any changes. However it is strongly recommended that you do not attempt to open a Quicken 2011 file in Quicken 2009 or 2010 as it could lead to data corruption due to new features not being available in the 2009 or 2010 release. You should manually create a backup prior to opening a 2009 or 2010 file in Quicken 2011.

Deleting Categories

In Quicken, categories are labels that track how much you're spending on particular types of items. If you try to delete an existing category, make sure that no transactions have been assigned to that category. This is to ensure that the reports you run display figures correctly as there will be no uncategorised income or expenses as a result of deleting a category which has previously been used.

Reckon Tools Backup Installation

To use the Quicken 2011 online backup feature, you will need to install the Reckon Tools Backup Desktop application.

Insert the Quicken 2011 CD into the CD-ROM drive and navigate to `d:\HAB\DISK1\Backup` folder (where d: is your CD-ROM drive) and run the `setup.exe`.

Other installation problems

If you experience any other problems during installation, consider whether any of the following may be the source of your problems:

- Are you logged onto your PC as the Administrator?
- Have you shut down all applications?
- Is your anti-virus software blocking your installation of Quicken?

If none of the above appear to be causing your problem, try installing Quicken in Safe Mode. For instructions on restarting your PC in Safe Mode, refer to your Windows Help. After you have installed Quicken in Safe Mode, do not try to open it immediately. First, restart your PC in normal mode and make sure you are connected to the Internet. Open Quicken and enter your Installation Key Code to Activate. If you do not have an Internet connection, click **Cancel** to close any activation messages and call Reckon Customer Service to Activate over the telephone.

Still having problems? Check the Quicken online knowledge browser at <http://www.quicken.com.au/Support/FAQs.aspx> and search the database for "error message".

Determine your upgrade path

Find your current Quicken version in the list below and check the upgrade path. If there is a tick in the row for your current version, then you can upgrade directly to Quicken 2011.

For example, if 'CashBook v8' appears in the row for your current version, then you must first upgrade your data file to CashBook 2004. Follow the upgrade instructions on the following pages carefully.

Required dlls for converting your data file is missing

Then you will need to upgrade your file through an intermediate version of Quicken (either Home & Business 2005/06 or Personal Plus 2006 or Personal 2006).

Note:

- If you upgrading from CashBook V8, CashBook 2002, CashBook 2003 or CashBook 2004 then you will need to upgrade to the Home & Business 2005/06 trial before upgrading to Home & Business 2011
- If you upgrading from Personal Plus V8, Personal Plus 2002 or Personal Plus 2004 then you need to upgrade to the Personal Plus 2006 trial before upgrading to Personal Plus 2011.
- If your upgrading from Personal V8 or Personal 2002 or Personal 2004 then you will need to upgrade to the Personal 2006 trial before upgrading to Personal 2011.

Internet connection is required to use the Quicken trials (Home & Business 2005/06, Personal Plus 2006 & Personal 2006) due to an activation process.

If you need to upgrade through one of the Quicken trials (Home & Business 2005/06, Personal Plus 2006 or Personal 2006) but don't have internet access then you will need to contact Quicken support to get assistance with upgrading your file.

Note: This doesn't apply to the CashBook 2004 or Personal Plus 2004 trial versions.

Prepare your company data file for upgrade

We strongly recommend that you follow the steps below to protect your company data and ensure its accuracy.

1. Back up your data file

1. In Quicken, open the data file you want to back up.
2. Choose **File** menu > **Backup**.
3. In the **Select the disk drive and path to backup folder** field, identify the drive that contains the backup media.
4. Click **OK** to start the backup.

For more information on how to back up, please refer to the User Guide (available on the Quicken CD) or in-product Help for "Backing up your data".

5. Validate your data file

Ensure the data file you are using is validated before upgrading your software. Validating a data file allows Quicken to verify its integrity. Choose **File menu > File Operations > Validate**. Find the data file you want to validate and click **OK**. You will need to repeat this process for every data file you want to upgrade.

6. Remove any passwords associated with your data file.

To remove your password from your data file, choose **File menu > Passwords > File or Transaction**.

7. Print a selection of Reports from the data file in your currently installed version

Print a record of all business Tax reports for previous periods (e.g. Tax Detail, BAS). You can use these Reports after upgrading to confirm the data which appears in the upgraded version is correct.

Note: Some reports in Quicken 2011 have different default settings to previous Quicken versions. In some

cases, these reports may require you to customise the report to obtain the same figures.

8. **Ensure ALL unapplied Adjustments/Credits are applied to an Invoice or deleted.**
9. **Delete all Scheduled Invoices and Payments (taking note of details).**
10. **Take note of your Quicken Settings / Preferences**

Some of the settings within your company file revert to the default settings of Quicken 2011. Make a note of your personal settings and preferences so you can apply these to your upgraded data file.

11. **Saved Reports may not be available after the conversion**

We recommend that you print any Saved Reports from your current version beforehand, for your reference.

12. **ABN and Branch number may need to be re-entered in your data file after conversion**

13. **If you have customised templates**

Customised Invoice and Estimate templates from your previous version only convert directly to Quicken Home & Business if you install Home & Business in the same installation directory as your previous version of Quicken, once the previous version has been uninstalled.

14. **If you have a linked investment account**

If you upgrade a Quicken company file that contains a linked investment account, the Investment Activity Report in Quicken 2011 will always report on all transactions from both accounts. To avoid this, you should un-link the accounts in your previous version prior to upgrading.

Upgrading your Quicken software

Reminder: before upgrading, have you:

- Printed a selection of reports from your original Quicken program.
- Created a backup of your original company file and validated it.

To upgrade from Quicken Personal v8 or Personal Plus v8 or CashBook v8, start on this page.

To upgrade from a different version, start on page 22.

Upgrading from Quicken Personal v8 or Personal Plus v8 or CashBook v8

In order to convert your data file to Quicken 2011, you need to step your data file up through CashBook 2004. The CashBook 2004 trial is available on the Quicken 2011 CD.

Install CashBook 2004 Trial

1. Make sure that your current version of Quicken (Personal v8 or Personal Plus v8 or CashBook v8) data file is backed up on disk then close Quicken.
2. Insert your Quicken 2011 CD into your CD-ROM drive. The installation screen automatically appears. If this does not happen, click the **Start** button and choose **Run**, then type `d:\autorun.exe` (where d is your CD-ROM drive) and click **OK**.
3. Browse CD. Then Browse to **CV** folder and then to **CBTrial** folder, then run **CashBook2004Trial.exe**
4. Click **Yes** when prompted to install CashBook 2004.
5. Click **Next** when the Welcome screen appears.
6. Select where you would like to install CashBook 2004 and click **Next**.

Note: You should install CashBook 2004 in the same installation directory as your previous version (default location is C:\Program Files\quickenw).

7. Click **Yes** to uninstall your previous version of Quicken. This will not affect your existing Quicken data.
8. Follow the prompts to uninstall your previous version of Quicken.

Note: Click **No to All** when prompted to remove all shared files.

9. When the uninstall process is complete, click **OK**.
10. Install CashBook 2004 (Browse CD to CV folder and then to CBTrial folder, then run CashBook2004Trial.exe).
11. Restart your computer to complete the installation of CashBook 2004.
12. Launch CashBook 2004 and upgrade your company file. If you have more than one company file, each must be upgraded by choosing **File menu > Open** and selecting the company file.
13. Once you have completed upgrading your file(s) to CashBook 2004, follow the instructions on page 22 – Upgrading from Quicken Personal 2002, Personal Plus 2002, CashBook 2003, Personal 2004, Personal Plus 2004, CashBook 2004, Personal 2005, Personal Plus 2005, Home & Business 2005/06, Personal 2006, Personal Plus 2006, Personal 2007, Personal Plus 2007, Home & Business 2007, Personal 2008, Personal Plus 2008, Home & Business 2008, Personal 2009, Personal Plus 2009, Home & Business 2009, Personal 2010, Personal Plus 2010, Home & Business 2010.

Note: If you encounter the message “The file contains one or more accounts that require access to features not currently activated in this copy of Quicken”, you will need to read Knowledge Browser article Q10227.

Upgrading from Quicken Personal 2002, Personal Plus 2002, CashBook 2003, Personal 2004, Personal Plus 2004, CashBook 2004, Personal 2005, Personal Plus 2005, Home & Business 2005/06, Personal 2006, Personal Plus 2006, Personal 2007, Personal Plus 2007, Home & Business 2007, Personal 2008, Personal Plus 2008, Home & Business 2008, Personal 2009, Personal Plus 2009, Home & Business 2009, Personal 2010, Personal Plus 2010, Home & Business 2010

You may directly upgrade your data file to Quicken 2011.

Note: When you upgrade to Quicken 2011, a backup of your original file is automatically placed in a folder called **Oldfiles** in your Quicken directory.

Follow the instructions below to upgrade your data file to Quicken 2011.

1. Ensure you have completed the instructions in section "Prepare your data file for upgrade" on page 18. Make sure you uninstall your current version of Quicken before continuing.
2. Insert the Quicken 2011 CD into the CD-ROM drive. The installation screen automatically appears. If this does not happen, click the **Start** button and choose **Run**, then type `d:\autorun.exe` (where d is your CD-ROM drive) and click OK.
3. Select your region.
4. Click **Begin**.
5. Follow the onscreen instructions.

Note: You may receive a message requesting that you exit and uninstall your previous Quicken version before installing Quicken 2011. When you uninstall your previous Quicken version you may be asked to remove shared files? Select **Yes to all**. Reckon strongly recommends you uninstall your previous Quicken version before you install Quicken 2011.

6. You may be requested to restart your PC to complete the installation. Select **Yes** to restart your computer, and click **Finish**.
7. The first time you open Quicken 2011, you will be required to Activate by entering your Quicken Installation Key Code (IKC). The activation process will take place automatically over the Internet. If you do not have an Internet connection, click **Cancel** on the messages that appear and call Customer Service to complete the process over the telephone.
8. The first time you open your company file in Quicken 2011, the upgrade process begins. Read the upgrade message and click **OK** if you want to continue. If you have a large data file, or if you have investment data, the upgrade may take several minutes.

Note: If you are upgrading from Quicken 2009 or 2010, your Quicken company files will not go through the upgrade process and they should open without changes.
9. Follow the prompts to set up your company file in Quicken 2011. Click **Done** when you have finished.

After you upgrade

Check your data in the upgraded version. Run the same reports you ran before upgrading and compare them to confirm that the data matches. If your data does not match the previous version, try to identify where the problem is. For example, it may relate specifically to categories or transactions.

- Check the Quicken settings and preferences against the settings you noted before upgrading your company file.
- Explore Quicken's many new features in What's new in Quicken under the Help menu.
- Back up your data file.

DO NOT OVERWRITE YOUR PREVIOUS BACKUP!

You may choose to back up your company file to a CD-ROM or other storage media. Make sure that you label each disk correctly and store it in a safe place in case you need them later. Do not overwrite this backup. (You can find instructions for backing up your data in the user guide, which is available on the Quicken 2011 CD-ROM.)

New Quicken users

Prepare to install Quicken 2011

Before you install Quicken, you need to:

- Log on to your PC as the Administrator or have Administrator rights.
- Close any programs running on your PC.
- Disconnect from the Internet.
- Disable your anti-virus and firewall applications.

THIS IS AN IMPORTANT DOCUMENT. PLEASE READ IT CAREFULLY.

This is a contract between Reckon Limited (ACN 003 348 730) (*Reckon*) and you. By using the Quicken software supplied with this document, and the related user guides and materials (together the *Software*), you agree to be bound by the terms of this Licence. This Licence covers copies of the Software provided for evaluation or trial purposes, subscription versions and non-subscription or full versions of the Software. Some Licence provisions may not be applicable to you, depending on the particular version of the Software you have purchased or if you are using the Software for evaluation purposes. The defined terms and the rules of interpretation in this Licence are set out in clause 12.

Important: There are a number of technical features within the Software that may affect your ability to continue to use the Software. These are outlined in more detail in the terms of the Licence, but in summary:

- you are purchasing the right to use the Software, not to own it;
- if you have been provided with a Trial Version, you may only use the Software on a temporary basis to evaluate the Software's functionality and suitability for your requirements;
- the Software contains registration and activation processes to guard against illegal copying;
- to continue using the Software, those processes require you to verify your compliance with the terms under which you are licensed to use the software (for example: the number of computers on which the software is installed) and to permit continued reactivation of the Software from time to time. This involves, in all versions, periodically verifying your licence details, and in the subscription version, renewing your subscription when it falls due. Reckon may also verify subscription customers during a subscription period and not only at renewal. You will also need to reactivate your Software if you want to reinstall it (for example, if you upgrade your computer or if you have a hard drive failure, and you may incur a technical support cost for this);
- when you purchase the Software or during the course of your subscription you will be provided with an installation key code. Please keep the installation key code in a safe place. You may need it when you first install or re-install

(if permitted) the Software and to reactivate the Software. Please note if you lose your installation key code that it will not be replaced by Reckon and you will not be able to install or reactivate the Software;

- you also need a licence key to reactivate your Software. In addition, with some older versions of the Software, you will not be able to re-install or reactivate the Software if you do not have your installation key code - see details below on Reckon's sunset policy;
- there will be no charge to activate the Software initially or to reactivate your Software when you verify your licence details or renew a subscription. Reckon may charge you a fee for technical support if it needs to reissue a licence key provided also that the version of the Software you are using has not been 'sunsetted' as explained below. 1. LICENCE

- Evaluation licence:* If Reckon has provided a Trial Version of the Software to you, your rights to use the Trial Version are solely as set out in clause 10.
- Licence to use:* Reckon grants you a personal, non-exclusive, non-transferable, limited licence to use the Software on the terms of this Licence for the period determined in accordance with clause 8.
- No transfer of copyright:* The Software is licensed not sold, despite any reference to "purchase" or "sale" in this Licence or in any invoice or purchase order for the supply of the Software. Reckon reserves all rights not expressly granted to you. Reckon Limited is the owner of copyright in the Software and retains ownership of the copyright and all

other intellectual property rights in the Software and is protected by copyright law and international copyright treaty.

2. YOUR PERMITTED USE OF THE SOFTWARE

- (a) *Single use licence*: If you have purchased a single user licence, you:
- (i) may install the Software once, on one computer only. However, if you wish to reinstall the Software (for example, if you need to install the Software on a replacement computer), then clause 3 will apply; and
 - (ii) must ensure that the Software is used by one person only at any one time.
- (b) *Additional licences*: Subject to any multi-user licence that you have obtained, if:
- (i) more than one person is to use the Software at the same time; or
 - (ii) the Software is to be installed on more than one computer

then you must obtain an additional licence for each additional person or computer.

- (c) *Premier Version*

If you have purchased a full version of QuickBooks Premier, this Licence entitles you to load the Software on up to three computers (for use by a single processing unit only on each computer) for use by up to three individuals simultaneously. If you wish to install the Software on more than three computers you must purchase additional licenses that will permit up to five users to simultaneously access a data file. If Reckon releases the next release of QuickBooks Premier while you are a member of the Advantage programme subject to its terms and conditions, you will be permitted to make a total of five installations.

If you have purchased a subscription version of QuickBooks Premier, this licence entitles you to load the Software on up to five computers (for use by a single processing unit only on each computer) for use by up to five individuals simultaneously. If you wish to install the Software on more than five computers you must purchase another full version or a subscription version of that software but for simultaneous access you will need to upgrade to an appropriate version that permits more than five users to simultaneously access a data file.

(d) *Accountant Edition*

If you are an eligible Professional Partner who has purchased a full version of QuickBooks Accountant Edition, this Licence entitles you to load the Software on up to five computers (for use by a single processing unit only on each computer) for use by up to five individuals simultaneously. In some special cases with written approval of Reckon only, certain Professional Partners may be allowed to load the Software on up to 25 computers. However, only 5 simultaneous users can have access to any single data file

(e) *Enterprise Version*

(i) If you have purchased the QuickBooks Enterprise version of the Software, this Licence entitles you to load the Software on up to ten computers with the option to load up to another 20 computers at the applicable charge (for use by a single processing unit only on each computer) for use by up to ten or more individuals up to a maximum of 30 (as permitted by the Licence purchased) simultaneously. You may not load the Software onto any further computers.

(ii) If you have purchased the QuickBooks Enterprise Accountants version of the Software, this Licence entitles you to load the Software onto one computer (for use by a single processing unit). You may not load the Software onto any further computers.

(f) *General restrictions:* You must not:

- (i) use or rely upon the Software for any purpose or in any manner for which the Software is not warranted;
- (ii) copy, reproduce, translate, adapt, vary, merge or modify or create any derivative work based on the Software;
- (iii) reverse engineer, decompile, disassemble, reconfigure or otherwise attempt to discover the source code of the Software; or
- (iv) sell, market, network, transfer, lease, license, sub-license, rent, lend or otherwise dispose of or distribute the Software or use the Software to provide a bureau service.

(g) *Licence verification:* Upon written request from Reckon, including by e-mail, you agree to provide Reckon with a signed certificate:

- (i) verifying that the Software is being used fully in accordance with this Licence, including user and machine limitations; and

- (ii) listing locations, types and serial numbers of equipment on which the Software is run.

You agree to allow Reckon to use and disclose any personal details provided to Reckon in connection with this Licence in accordance with Reckon's then current privacy policy displayed on Reckon's website.

- (h) *Audit rights:* Reckon may also audit the number of copies of the Software in use or possession by you, the equipment on which the Software is installed or used and the number of users using the Software. Audits will be conducted in your normal business hours, or upon reasonable prior written notice, at Reckon's expense. If the audit reveals underpaid or unpaid fees due to Reckon, you will be invoiced for them based on Reckon's then current price list, and if these exceed 5% of the license fees you have already paid, you will also be invoiced for the cost of the audit.

3. PRODUCT ACTIVATION AND VERIFICATION

- (a) *Initial registration and verifying licence details:* This Software may contain technology that protects Reckon against illegal copying. As a consequence, you may be required to:
 - (i) register your details during the initial installation (including your name, contact details and details of the hardware on which the Software will be installed (if this is not done automatically by the Software));
 - (ii) if you have a full version, have the Software reactivated periodically thereafter by verifying your licence details to confirm you are using the Software in accordance with these Licence terms;
 - (iii) if you have a subscription version, have the Software reactivated (on payment of Reckon's renewal fee and verification of your licence details) if you wish to renew the subscription;
 - (iv) have the Software reactivated by Reckon if you wish to re-install the Software (for example, if you would like to install the Software on a new computer or if you have a hard drive failure and need to reload your Software); and
 - (v) provide to Reckon the details of your installation key code and product key code for the Software as part of the reactivation process.

You agree to activate or reactivate the Software within a reasonable time or within such time as the Software prompts you to do so.

- (b) *Key codes:* Each copy of the Software is provided with a unique installation key code (which may appear on the packaging or the cover of the media on which the Software is contained). You should keep the installation key code safe. As per clause 3(a)(v), you will be required to provide your installation key code to Reckon when you reactivate your Software.
- (c) *Manner of verification:* You must verify your licence details in the manner required by Reckon from time to time (which may include email or on-line registration via the Internet). The Software may prompt you as to the required manner of verification.
- (d) *Charges for reactivation:* Reckon will not charge you to activate the Software initially or to reactivate your Software when you verify your licence details or renew a subscription, unless you have lost your installation or licence key code. - (i) in the case of a subscription version of the Software, during the period for which you have paid the relevant subscription fees (unless further releases of the Software in question are discontinued); and
 - (ii) in the case of a full version of the Software, there is a 'sunset period' during which technical support may not be available for that version. The sunset period for a version will commence on the earlier of:
 - (A) 2 years after the date on which you first installed the version on your computer; or
 - (B) the date Reckon releases the second successive Upgrade to that version.

- (a) *Software provided on an 'as is' basis:* Subject to clause 7(b), Reckon provides the Software to you on an "as is" basis and without any representations by Reckon or any of its

authorised distributors regarding the use, performance, or results of the use of the Software.

- (b) *Defects in media*: Reckon warrants that the media on which the Software is recorded is free from defects in manufacture for a period of 90 days from the date of delivery. During this period, if you return the Software to your place of purchase, Reckon will replace any defective media on which the Software was supplied and any Software on that media, free of charge, unless you caused damage to the media due to poor handling.
- (c) *No guarantee that Software will be error free or that its use will be uninterrupted*: While Reckon has endeavoured to make sure that the Software works substantially as per the specifications published by Reckon from time to time, Reckon does not guarantee that the Software will work on all computer hardware platforms or configurations and makes no warranty that the Software will be error free, that its use will be uninterrupted or that it will be fit for your purpose.
- (d) *Internet access, telecommunications networks, firewalls and security*: Reckon does not guarantee connections to its online activation server as these may be dependent upon third party networks and security measures over which Reckon has no control.

7. LIABILITY

- (a) *Certain rights cannot be excluded*: The Trade Practices Act, 1974, and other laws may imply certain conditions and warranties into this Licence and give you certain rights and remedies that cannot be excluded or modified. This clause 7, and the limited warranties provided in clause 6, do not exclude or modify any of those rights if to do so would contravene that law or make any part of this Licence void.
- (b) *Exclusion of warranties*: To the full extent permitted by law, Reckon excludes all conditions, warranties and rights that may be implied into this Licence. If conditions, warranties or other rights for your benefit are implied in this Licence or otherwise conferred by law and it is not lawful to exclude, restrict or modify them, then those conditions, warranties and other rights will (but only to the extent required by law) apply to this Licence.
- (c) *Limitation of implied terms*: Reckon's (and its distributors') liability for breach of any implied conditions or warranties that cannot be excluded is limited, to the extent permitted by law and at the option of Reckon, to replacing or re-supplying the goods or services or their equivalent again or the payment of the cost of having the goods or services or their equivalent replaced or supplied again.

- (d) *General exclusion and limitation:* Other than as set out in clauses 7(b) and 7(c), and to the full extent permitted by law:
- (i) Reckon (and its authorised distributors) will not be liable to you or any other person for any direct or indirect loss, damages, liability, costs or expenses suffered by you or any other person relating to the performance or non-performance of the Software or any breach of this Licence or the supply of the Software or in connection with, but not limited to, the Online Services, use of tax tables, use of third party hardware (for example but not limited to Postec services) or provision of technical support (whether by telephone or remote access or other means); and
 - (ii) Reckon's maximum liability for damages arising in connection with this Licence or the supply of the Software is limited to the amount paid by you for the Software.
- (e) *Your liability to Reckon:* You agree that Reckon (and its authorised distributors) will not be liable, other than as expressly set out in this Licence, and that you will indemnify Reckon (and its authorised distributors) from any liability, loss, damage, costs or expenses which you may suffer or incur as a result of your use of the Software (including any claims made against you by third parties).
- (f) *Use of Software is not provision of professional advice:* The information contained in this Software may include features designed to assist you in complying with the requirements of the relevant legislation; e.g., superannuation. If the Software contains features to assist with superannuation, e.g., superannuation guarantee requirements, then Reckon does not warrant that the relevant reports will be compliant with legal requirements, as these change from time to time. You agree it is your obligation to ensure that deductions and rates used for deductions for superannuation, taxation (of any nature) and any other deductions/contributions calculated using the software are correct from time to time and at the applicable time and that nothing in the software constitutes professional advice in relation to these matters. The help contained in this Software is not a substitute for professional advice. Legal and accounting advice should be obtained before taking any action in reliance on this Software. The software is also not financial product advice. In addition any tax tables (which are included with certain versions of the Software, e.g., QuickBooks and Payroll Premier) that might be supplied with this Software are also changed from time to time and you should consult with your professional adviser before relying on the tax tables. Reckon does not warrant that the tax tables are up to date at your date of purchase. In providing you with the tax tables,

Reckon is not engaged in rendering legal, accounting or other professional services. If legal advice or other expert assistance is required, you should seek the service of a competent professional.

- (g) *Reckon has no responsibility for recommendations:* Reckon, its employees, agents, contractors and the authors disclaim any and all liability and responsibility to any person, whether a user of this Software or not, in respect of anything (including, without limitation, any error in or omission from this Software) and of the consequences of any actions taken or omitted to be taken in reliance, whether wholly or partially, upon all or any part of the content, recommendations or help contained in this Software.
- (h) *Corruption of data and on-line access:* To the full extent permitted by law, Reckon and its authorised distributors disclaim all liability for any corruption of data, inability to access data, loss of data, breach of privacy, or downtime as a result of or arising from the use of any online link available between the Software and another server including without limitation in connection with any Online Services.
- (i) *On-line services:* Reckon makes no warranty or representation in connection with the Online Services, the responsibility for which rests with the relevant provider of such Online Services.

8. TERM AND TERMINATION OF LICENCE

- (a) *Licence Term:* Unless this Licence is terminated earlier in accordance with its terms, your right to use the Software in accordance with this Licence continues:
 - (i) in the case of a subscription version of the Software, for an initial period of 12 months from the date of registration of the Software. This Licence will automatically renew for a further 12 month period upon the payment of Reckon's annual subscription fee. If the annual subscription fee is not paid on or before the termination of the current 12 month period, this Licence will automatically terminate; and
